

Active Investor visa requirements

From 1 April 2025, the Active Investor Plus visa is being updated. Active Investor Plus visa applicants will be required to choose between two investment categories - Growth or Balanced - offering a broad range of investment options and benefits.

Greener Pastures investment options

A requirement of the AIP Visa is that you make investments in New Zealand Trade and Enterprise (NZTE) approved qualifying investments over a required period:

- USD2.9 million*: if investing directly into approved New Zealand businesses or Managed Funds
- USD5.8 million*: if investing into listed equities, philanthropy, property development or bonds.

Greener Pastures New Zealand is the only New Zealand provider that has designed its whole business around the requirements of the AIP visa, including its investment products.

Our investment products have a particular emphasis on providing diversified risk and are proprietary investment options offered only to Greener Pastures clients. They will be managed by Origin Capital Partners, the parent company of Greener Pastures and an established fund manager based in New Zealand.

Greener Pastures has designed and established its first qualifying investment, the "Greener Pastures Diversified Fund", which enables residency to be secured with a USD2.9 million* investment. The Fund has a number of structural design features advantageous to the AIP visa. This fund is currently open to AIP visa holders for investment.

Greener Pastures expects to bring an approved "direct investment" option to market in 2025, also meeting the AIP visa requirements with a USD2.9 million* investment.

Greener Pastures Diversified Fund - Key features



Minimises total investment required

The visa requires investment of either USD2.9 million* or USD5.8 million* to secure residency status, depending on the class of investment. Investment in the Fund minimises the required investment amount to USD2.9 million*.



Minimises the timeframe to residency

Investment in the Fund enables the investor to be eligible for permanent residency in as little as three years, the shortest timeframe possible.



Efficient allocation of capital

An investor will be considered fully invested from the date of commitment to the Fund, ahead of an investor's capital being called.



Early liquidity optionality

At the end of the investment period, the investor will be eligible to apply for a Permanent Residency visa. At that point, invested funds are not bound by any requirements linked to the AIP visa programme. As such, the investor may wish to exit their investment through a sale of units in the Fund. The sale of units during the life of the Fund is permitted. Greener Pastures will work with investors to find potential buyers.

It is expected that a potential pool of buyers could be Greener Pastures investors at the beginning of their four-year investment period.



Net of fees

For the purpose of compliance with the AIP visa programme, the required investment will be net of fees. (Rather than being charged on top of an investor's investment).

Approval in principle and movement of funds


Initial determination of your application is completed by Immigration New Zealand and if successful, approval in principle is granted. Immigration New Zealand may request further information in order to assess the application.

You must apply for a work visa, to allow you to arrange the transfer to and investment of funds in New Zealand. Your work visa will have travel conditions allowing for multiple journeys to New Zealand during this period.

You may request an extension of up to six-months if there is sufficient evidence of reasonable attempts to transfer and invest the nominated funds or funds from the sale of nominated assets within the initial six-month time period.









You must transfer your nominated funds into New 7ealand within six-months of receiving approval in principle.



The funds must be transferred into acceptable holding investments.

^{*}i.e. New Zealand government bonds, term deposits within New Zealand registered banks, deposits in a New Zealand bank account or other acceptable holding investments such as the Greener Pastures cash management account.





Your investment period

To obtain a conditional resident visa, you must make a full investment into one of the acceptable investments.

- The investment period then begins and the days in country requirement begins.
- You must spend a minimum number of days in New Zealand dependent on your chosen investment category (Growth or Balanced).
- After 24-months, there is an investment retention check-in. For the Growth category investors, this occurs again at the 36-month mark, and for Balanced category investors at the 60-month mark.
- At the end of the investment period, Immigration New Zealand ensures that all visa conditions are met, so all visa conditions can be lifted and permanent residency granted.



Hear from those who have relocated to New Zealand

We emigrated to New Zealand in 2020, arriving a few days before the border closed due to Covid. We had chosen New Zealand, among other reasons, mainly for its democracy, its spectacular nature and beauty, its self-sufficiency, its safety, its relative remoteness, its friendly people, its magnificent lifestyle, its good medical facilities, etc. All of these factors were important to us.



From a business perspective, our principal concern was the logistics of operating from New Zealand a travel company focused on international HNW clients based in over thirty countries and traveling more or less everywhere. We quickly realized that it was neither easier, nor more difficult than when we lived in Los Angeles; the difference was nominal.

New Zealanders are naturally outgoing. We found ourselves quickly making friends, meeting new people, and being drawn into the Kiwi way of life. In short order we have become a part of several interesting circles. It has all been fantastic.

New Zealand does not have a strong philanthropic history. In 2020, we began our own foundation, the Celestielle Charitable

Trust, whose mission is to provide all-expensepaid travel scholarships to deserving and Kiwi students from economically challenged families. Many people wondered if there was a catch or if it was even for real. Now that it is established, we find Kiwis incredibly appreciative.

Though it is an eleven-hour flight from Los Angeles and a three-hour flight from its nearest neighbours, Australia and Fiji, it has been effortless keeping in touch with the rest of the world. New Zealand's telecommunications are excellent and for much of the year the time is only three hours difference from Los Angeles.

Though our business model mandates a significant amount of travel for us, we have no intention of ever residing anywhere else.
